



If you are the close family member of an EU/EEA/Swiss citizen, or the close family member of their spouse or civil partner, you may be eligible for status under the EU Settlement Scheme (EUSS). If you want to enter and remain in the UK, you need to submit an application from abroad first.

Your close family member, or their spouse or civil partner, can be your "relevant sponsor" if they are already covered by the EUSS. You will be able to apply to join your relevant sponsor in the UK at any time in the future.

Your relevant sponsor must have started living in the UK before 31 December 2020 and have a valid pre-settled or settled status. If your relevant sponsor is the spouse/civil partner of your close family member, their marriage/civil partnership must have existed before 11pm on 31 December 2020.

If your family member is a British citizen, Irish citizen, person from Northern Ireland or a Frontier Worker, please get in touch.

# Am I eligible to join my relevant sponsor and how do I apply?

#### **Spouses**

The marriage/civil partnership must have existed on 31 December 2020. If you were not in one of these relationships as of 31 December 2020, please check below if you could apply as a "durable partner". For family members of Swiss citizens only: the marriage/civil partnership must exist before 31 December 2025.

#### **Durable partners**

The relationship must have started and been durable by 31 December 2020. The Home Office expects to see two years of cohabitation, or other evidence of the relationship being serious by 31 December 2020; and evidence that the relationship is still existing.

#### Children and grandchildren under 21

Children and grandchildren under 21 are eligible to apply without proving dependency. They will get the same status as their sponsor.

# Dependent children and grandchildren over 21 and dependent parents or grandparents

Applicants will need to show dependency: that without financial or material support from the relevant sponsor they cannot meet their essential living needs. Dependency could be due to health reasons or need of care.



# I'm an EU/EEA/Swiss citizen, what do I need to apply?

- A valid biometric passport or ID card
- Proof of your relationship (see overleaf)
- Proof of dependency, if applicable (see overleaf)
- Download the Home Office EU EXIT: ID Check App to a smartphone to scan the biometric ID.



## CHECKLIST OF DOCUMENTS AND EVIDENCE YOU MUST PROVIDE

Proof of the relationship

### For spouses:

Certificate of marriage dated before 31 December 2020

#### For civil partners:

Certificate of civil partnership dated before 31 December 2020

#### For durable partners:

Evidence of cohabitation, joint responsibility of a child, joint finances, bank transfers, joint ownership of a property dated before and after 31 December 2020

#### For children under 21:\*

Birth certificate of the child, adoption certificate

#### For dependent children over 21:\*

Birth certificate of the child

#### For dependent parents:\*

Birth certificate of the sponsor

### Proof of the dependency, if applicable

#### Financial dependency:

Bank or money transfers, payments of rent or mortgage, bills, groceries, petrol, insurance, medicines etc.

#### **Medical dependency:**

GP or consultant letters, medical certificates, disability certificates etc.

#### **Evidence of the applicant's circumstances:**

University documents, official legal documents, certificates of a family member, employment documents etc.

Provide original documents and certified translations of documents that are not in English
