# Settled in Wales



**Settled is a charity set up in 2019 to help EU citizens and their families living in the UK whose rights were affected by Brexit.**

**We provide free immigration advice and support to people with status, or looking to gain status, under the EU Settlement Scheme (EUSS). Settled is an organisation accredited with the Office of Immigration Services Commissioner (OISC) at Level 3. Settled is a UK-wide charity with strong roots in Wales – our head office is in Newport city centre.**

## WHAT WE DO

We can assist with a variety of issues relating to the EUSS, for example:

- You have pre-settled status and want to apply for settled status.
- You haven't applied yet, but you were in the UK before 31.12.2020 and have good reasons and evidence for why you haven't yet applied. This is termed a late application.
- You want to bring your close family members to the UK.
- Your application to the EUSS has been rejected.
- You have problems accessing your digital status.
- You are having problems accessing welfare benefits, public services, or understanding your rights.
